As a parent I have used this park frequently over the last 9 years and love the fact that we have such a wonderful space in the centre of town. Myself and my family have participated in many of the activities you have planned over the last few years and have enjoyed the sense of community and ownership you have instilled in park users.

In viewing your plans, I was delighted to see the way in which you had brought together play equipment and natural elements which will enhance not only the functionality of the park, but its look and biodiversity.

As someone with a background in nature-based play, this biodiversity is something I have been watching keenly as your plans have developed. The mixture of native bulb planting, the introduction of new species of tree and space for seasonal planting are all positive steps to both enhance floral biodiversity and encourage both animal species into the park.

Further to my personal views, I am also a teacher. This year I have two children with physical disabilities and have been hit constantly with challenges when trying to arrange sessions in the community due to a lack of appropriate resources which they can use.

We recently discussed the development of the park in class and I can't begin to explain the excitement and sheer joy expressed when they realised a space was being created that not only met their needs, but allowed them to play alongside their friends and family members, rather than separate to them. Letter of support for long term lease application.

Being inclusive should be at the heart of not only education but of all activities that take place within a forward thinking, mindful society. There are many social and educational barriers to those with Special Educational Needs and Disabilities (SEND). Statistically and despite best efforts children with a SEND are

far more likely to struggle with education. In 2017 the Department for Education reported that, at Key Stage 2 level, only 14% of children with SEND reached the expected level for reading, writing and maths (in contrast to 62% of children without SEND).

Across the world, people with disabilities have poorer health outcomes, lower educational achievements, less economic participation and higher rates of poverty than people without disabilities. This is partly because people with disabilities experience significant barriers in accessing basic services, including health, education and employment.

Any caring society would feel a moral and ethical responsibility to ensure that organisations such as Catherine Street Inclusive Play Park have support, security and capacity for growth. That's why granting a long-term lease is such an important and rewarding thing to do.

When my sons were diagnosed with a rare genetic condition which has left them both severely sight impaired, I was alarmed to discover the connection between SEND and depression and mental health issues. Many visually impaired children are isolated because of lack of transportation, inclusivity, opportunity and the anxiety of going out in public places. This can lead to loneliness and depression.

Catherine Street Inclusive Play Park advocates mindfulness and creativity in a very positive way. This ethos helps considerably in allowing social interaction, friendships, and positive mental health. There is so much of the world that is difficult to access for those with an SEND, inclusivity and places like the park should be at the heart of every community in the UK. They are a valuable instigator for change and can only enrich the experiences of those who participate.

I fully support the application for the long term lease and encourage the council to support this wholly worthy organisation.
